Any addendum to the contract shall include names and titles. Vehicles may be damaged if winched, towed, unlocked or left on unattended premises. I recognize the difficulty involved and I agree not to hold TOWS ARE US responsible for such damage should it result. I hereby authorize TOWS ARE US to tow these vehicles and acknowledge that TOWS ARE US will not be held responsible for personal articles in case of fire or theft. The above named company or private property owner must give thirty "30" days written notice of cancellation before this contract is cancelled by certified mail. I understand that I will incur no fee for the aforementioned services. \*This does not include personalization of signs posted on the premises. It is also my understanding that TOWS ARE US will seek compensation for services rendered from the owner of said vehicles, vessels and or units.
